We respect your privacy and aim to collect as little personal information as possible.

What information we collect: You can read our website without giving us any personal information. We may collect basic, non-personal information such as the type of browser you use, which pages you visit, and your general location. This helps us understand how the site is used. If you contact us using the "Contact Us" form, we will ask for your name, phone number, and email address so we can respond to you.

Do not use the contact us form to spread hate. You may appreciate that as an opposition party, we believe we have a duty to criticise the government on matters we disagree on; we take reasonable steps to do so with decorum, albeit robustly- our write-ups go through many rounds of scrutiny. Where visitors disagree with our position on such posts (statements/press releases), they too have the task to rebut, but we kindly ask them to do so with decorum. Our deeply polarised country needs it.

Donations: If you donate via PayPal or by bank transfer, we do not collect or store your bank or payment details. These are handled securely by the payment provider or your bank.

How we use your information: We use contact details only to reply to your messages and engage in constructive political discussion. We do not use your information for marketing or sell it to anyone.

Cookies: If you use our website, we may use cookies for basic website functionality and analytics. You can control or block cookies through your browser settings.

Sharing your information: We do not sell or rent personal information. We only share information if required by law or to protect the security of the website.

Keeping your information safe: While no website can be completely secure, we take reasonable steps to protect your information.

External links: Our website may link to other websites. We are not responsible for how those sites handle your data.

Your choices: You do not have to provide personal information other than that requested on this application for or to use the website. If in inadvertently shared any personal information with us, you can ask us to delete the personal information you have shared with us, but please tell us what it is – give us as much information about it as possible so that we can act without delay.
